## Distinguished Delegates,

Home to one fourth of humanity and endowed with abundant human and natural resources, the SAARC region has vast potential for socio-economic development and improving the quality of life of the peoples. Moreover, with a consumer market of 1.7 billion people, South Asia is one of the fastest growing economies in the world. These advantages provide tremendous potential for enhanced intra-regional trade for sustained economic growth. Our ultimate objective is to achieve the South Asian Economic Union in a phased and planned manner through Free Trade Area, a Customs Union, a Common Market, and a common Economic and Monetary Union, as desired by our leaders during the Eighteenth SAARC Summit.

In order to achieve regional economic integration, intra-regional connectivity is very important. Therefore, we are working on the SAARC Motor Vehicles Agreement, SAARC Railways Agreement and SAARC Air Services Agreement. SAARC Passenger and Cargo Ferry Service is likely to commence soon between India and Sri Lanka, that will then be extended to connect Bangladesh, the Maldives and Pakistan.

We are also working on further improvement of SAARC Visa Exemption Scheme. This will also facilitate promotion of people-to-people contacts and economic relations among the Member States of SAARC.

With the expertise and experience that the distinguished delegates from PTB, the Member States and the private sector bring, I am confident of a fruitful outcome of the deliberations of this Workshop, leading eventually to the successful implementation of Phase 3 of the Project, aimed primarily at improving access to trade and demand-oriented quality infrastructure services.

I once again wish to thank PTB for instituting this Project. We look forward to continuing fruitful collaboration with PTB in the years to come.
